1. Preamble

Indian Institute of Management Visakhapatnam is an Institute of National Importance under IIM Act 2017. The Institute invites applications from eligible candidates for the post of Professor of Practice (on Contract) from distinguished experts who have made remarkable contributions in their professions in management and allied knowledge areas, to contribute to the efforts of the Institute in nation building. Appointment of Professor of Practice will be on Part-time/Full-time basis and as per the requirements of the Institute and broadly as per the provisions of 'UGC Guidelines for Engaging Professor of Practice in Universities and Colleges.' 2. General Terms & Conditions:

- a. Information about the academic areas and activities, research and allied knowledge areas is available on the website of the Institute.
- b. This advertisement for the position of Professor of Practice is on a rolling basis.
- c. These positions will be funded by the Institute from its own resources.
- d. Interested candidates may submit their applications any time during the year. However, strictly based on need, applications will be considered for screening and further selection process, from time to time.
- e. The closing date for the first lot of applications is 15 April 2026 (Wednesday). Subsequent closing dates will be notified thereafter, based on need.
- f. Mere fulfilment of qualifications and experience does not entitle an applicant to be shortlisted. The Institute reserves the right to restrict the candidates to be called for the selection process to a reasonable number, based on relevant criteria, higher than the minimum prescribed.
- g. Prospective applicants and shortlisted candidates are advised to visit the website of IIM Visakhapatnam (www.iimv.ac.in/careers) regularly, for updates. Amendments, corrigenda (if any), will be placed on the Institute website only.
- h. The Institute will communicate only with short-listed candidates. No correspondence from applicants shall be entertained during the recruitment process.
- i. In all matters of recruitment such as screening, shortlisting, selection, the interpretation and decisions of the relevant Committees and/or the Competent Authority of the Institute shall be final and binding.
- j. The Institute reserves the right to act and take decisions as deemed fit, in all matters relating to (i) eligibility; (ii) acceptance or rejection of the candidature; (iii) incomplete or incorrect information (if any) furnished by the applicant; (iv) shortlisting and selection. No request or correspondence of any kind in this regard would be entertained.
- k. The Institute also reserves the right to restrict, enlarge, modify or alter the requirements or recruitment process of professors of practice, in whole or part, if

such need arises, without issuing any further notice or assigning any reason thereof.

- l. The Institute reserves the right not to fill up any / all position(s); or not select any candidate without assigning any reason thereof. The Institute also reserves the right to cancel the recruitment/ selection process at any time.
- m. Canvassing in any form will be a disqualification.
- n. Disputes (if any) shall be subject to the jurisdiction of competent courts of the city of Visakhapatnam and Andhra Pradesh.
