- Paper presented if part of edited book or proceeding then it can be claimed only once.
- For joint supervision of research students, the formula shall be 70% of the total score for Supervisor and Co-supervisor. Supervisor and Co-supervisor, both shall get 7 marks each.
- *For the purpose of calculating research score of the teacher the combined research score from the categories of 5 (b) Policy Document and 6 Invited lectures/Resource Person/Paper Presentation shall have an upper capping of thirty percent of the total research score of the teacher concerned.
- The research score shall be from the minimum of three categories out of six categories.

II. Screening of candidates: Criteria and Process

1. The Screening Committee will draw a list of all the candidates indicating the research score scored by them in descending order i.e. starting from the candidate getting the highest marks towards the candidates getting the lower marks.
2. For appointment to the post of Associate Professor in the University Departments, there is a requirement of a total research score of Seventy-Five (75) as per criteria given in Section I of this document.
3. The time taken by candidates to acquire M.Phil. and / or Ph.D. Degree shall not be considered as teaching/ research experience to be claimed for appointment to the teaching positions.
4. The period of active service spent on pursuing research degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment/ promotion.
5. In case of any dispute with regard to screening of the applications, the decision of the Screening Committee shall be final.
6. The status of short-listing will be made available on the university website for applicant's information.

III. Important Note

1. The entire onus of the content/authenticity of the information being uploaded in the form of application and its attachments shall exclusively rest with the applicant in terms of eligibility for recruitment and for subsequent selection through due process.

1. The qualification shall be as per UGC (Minimum Qualification for Appointment of Teachers and others Academic Staff in the Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulation 2018.
2. Applicants are required to apply online in the prescribed format with complete and correct information with desired attachments. The online link will be available live from 11 March 2026 and will be closed on 10 April 2026. The applicant will be solely responsible for the authenticity of the submitted information.
3. Applicants are required to register on Samarth recruitment portal through the link available on the University website www.sdsuv.ac.in through Link: <https://sdsuvrec.samarth.edu.in> to fill the on-line application form. The applicants are required to read the details carefully before filling up the form.
4. Applicants should possess the prescribed qualifications and experience as on the closing date of application, as prescribed by the University from time to time for the respective posts. II. Shortlisting of candidates: Criteria and Process
