DETAILED VACANCY CIRCULAR

Applications are invited from the eligible officers for filling up the following posts in the Directorate of Sugar & Vegetable Oils (DSVO) – an attached office of the Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution:-

(i) One post of Joint Director (General Cadre) in Level-12 of the pay matrix (Rs.78,800-2,09,200) a General Central Service Group 'A' Gazetted post (Non-Ministerial). As per RRs (Notified vide G.S.R354 dated 20/10/2019, the method of recruitment to fill up this post is by "Composite Method [promotion/deputation (including short-term contract)]"; and

(ii) One post of Deputy Director (General Cadre) in Level-11 of the pay matrix (Rs. 67,700-2,08,700) a General Central Service Group 'A' Gazetted post (Non -Ministerial).
